## **Save the date — workshop on contaminants of emerging concern is May 1–2**

The State Water Resources Control Board will conduct a two-day workshop on contaminants of emerging concern (CECs) May 1–2 in Sacramento. CECs encompass a vast number of chemicals that are generally unregulated in the U.S. including pharmaceuticals, flame retardants, pesticides, personal care products, commercial and industrial products, fragrances, hormones, antibiotics, and nanoparticles. The workshop will share the current state of knowledge on CECs and study efforts underway in the Bay-Delta and other areas of California and will review lessons learned.

May 1 topic is The State of Knowledge and Practice in California, 10:00 a.m. – 5:00 p.m.

May 2 topic is Monitoring for Contaminants of Emerging Concern in the Sacramento-San Joaquin Delta, 9:30 a.m. – 4:30 p.m. The Delta Stewardship Council will co-sponsor this day.
