Final Delta ISB water quality review now available

The Delta Independent Science Board (Delta ISB) has finished its review of the scientific basis for assessing water quality in the Delta. This review focuses on contaminants and nutrients in the Delta, and on how findings about them have been sometimes used and sometimes neglected in decisions related to ecosystem health. With the completion of this review, the Delta ISB is committed to undertake an active outreach effort to engage the community about the findings and recommendations from this review. Central Delta Corridor Partnership announces workshops

The Delta Conservancy is coordinating a 9-month public process that will bring together land owners, agencies, and interested stakeholders to collaboratively develop an initial coordinated corridor strategy for management and restoration of publicly funded lands along the Central Delta corridor. This planning effort will consist of a public workshop to introduce the partnership and planning process, a 1.5-day charrette workshop on August 8 and 9, a series of half-day workshops to develop and discuss strategies, and a final public workshop to present the draft planning document and solicit input. Californians and the Environment survey

When compared with national polling, Californians are much more likely to say that global warming is extremely or very important to them personally. A majority of likely voters see global warming as a very serious threat to California's economy and quality of life, and a solid majority say that the effects of global warming have already begun. This may help explain why most Californians are in favor of the State making its own policies to address climate change. These and other key findings in the July Public Policy Institute of California [Statewide Survey](#) were presented by researcher Alyssa Dykman at a Sacramento briefing last week.
