E. Joaquin Esquivel was appointed to the State Water Resources Control Board by Governor Jerry Brown in March 2017, designated by Governor Gavin Newsom as Chair in February 2019, and reappointed to the board by Governor Newsom in 2021. Previously, he served as Assistant Secretary for federal water policy at the California Natural Resources Agency in the Governor's Washington, D.C. office, where he

facilitated the development of policy priorities between the agency, the Governor's Office, the California Congressional delegation, and federal stakeholder agencies.

For more than eight years prior to that, Joaquin worked for U.S. Senator Barbara Boxer of California, most recently as her legislative assistant covering the agriculture, Native American, water, oceans, and nutrition portfolios, in addition to being the director of Information and Technology.

He was born and raised in California's Coachella Valley. He holds a BA from the University of California, Santa Barbara in English.

He has led approximately 180 CCWD staff to reliably serve water to over 520,000 residents in northern and eastern Contra Costa County since January 2024. Before joining CCWD, Kyle was the Public Works Director for the City of Benicia, a full-service city in Solano County. Kyle began his career almost 20 years ago at the State Water Resources Control Board where he helped communities build water treatment infrastructure, develop water recycling projects, draft water quality standards for the Bay-Delta, led a water rights change petition hearing, and enforced water rights statutes/regulations. Kyle Ochenduszko is also a commissioned officer in the California State Guard, currently assigned to the Work-for-Warriors program helping service members find careers apart from military service. In his spare time, he enjoys spending time with his family outdoors. Kyle is a licensed Professional Engineer, has bachelor's degrees in mechanical and aeronautical engineering from the University of California, Davis, and a master's degree in public administration from the University of Southern California.


Alice Towey


