PROGRAMS AND SERVICES

Earthquake website updated: New Maps, Tables, and Resources

ABAG has recently updated the Earthquake and Hazard Program Website working with the US Geological Survey (USGS) and a technical advisory committee. All new shaking scenario maps will be available by the end of September. ABAG also developed a map depicting the probabilities of peak ground motion within the Bay Area using a 10% probability in 50 years. Other features on the website include a table describing the Modified Mercalli Intensity scale, making it easier for residents to understand what quake intensities mean for their home and gain a better understanding of risk. A better understanding of risk can help residents prepare for earthquakes, such as retrofitting their homes.

In addition, ABAG has developed an innovative map which identifies the shaking scenario most likely to be the highest hazard for different areas across the Bay Area. Previously, the Website focused largely on the San Andreas and Hayward Faults, but we realized that for many people not in the core of the Bay Area, other shaking scenarios could affect them and their homes more intensely. The new map indicates that there are actually 15 scenarios that will most likely affect Bay Area residents.

The Website also has a new look and flow, with a new template and reorganized content featuring the following categories: Hazards, Projects, and Topics, in addition to County-specific Hazard pages to guide residents to more relevant local resources.
