### NOTICE OF OPPORTUNITY TO COMMENT

#### PROPOSED APPROVAL OF AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE SACRAMENTO RIVER AND SAN JOAQUIN RIVER BASINS TO EDIT AND UPDATE LANGUAGE

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Central Valley Regional Water Quality Control Board's (Central Valley Water Board) amendments to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins to Edit and Update Language (Basin Plan amendment). The Basin Plan amendments were adopted by the Central Valley Water Board on March 27, 2014 (R5-2014-0037), and are available for review at: [http://www.waterboards.ca.gov/centralvalley/water\\_issues/basin\\_plans/changes.shtml](http://www.waterboards.ca.gov/centralvalley/water_issues/basin_plans/changes.shtml)

**REQUEST NOTICE OF STATE BOARD MEETINGS.** The State Water Board will separately publish an agenda for the meeting at which it will consider adopting a resolution approving the Basin Plan amendments. Oral comments at the State Water Board meeting generally will be limited to a summary of the written comments submitted during the written comment period. Persons interested (including those who submit oral or written comments to the Central Valley Water Board and State Water Board) in receiving notice of the meeting at which the State Water Board will consider approving the Basin Plan amendments **must subscribe** to: [http://www.waterboards.ca.gov/resources/email\\_subscriptions/reg5\\_subscribe.shtml](http://www.waterboards.ca.gov/resources/email_subscriptions/reg5_subscribe.shtml) and check the box for *Basin Plan Triennial Review for the Sacramento & San Joaquin River Basins*. **SUBMISSION OF WRITTEN COMMENTS.** Persons interested in the Basin Plan amendments are encouraged to submit comments electronically. Comment letters **must be received by 12:00 noon on July 25, 2014**. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise. 

**REQUIREMENTS FOR SUBMITTING COMMENTS** (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

1. Comments must specifically address the final version of the Basin Plan amendments adopted by the Central Valley Water Board.
2. If the Central Valley Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Central Valley Water Board to each comment was inadequate or incorrect.
3. The commenter also must include either a statement that each of the comments was timely raised before the Central Valley Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Central Valley Water Board.
