## WRRDA of 2014 – Listening Session and Public Input

On 10 June 2014, the President signed into law the Water Resources Reform and Development Act of 2014 (WRRDA 14). As we embark upon the important task of implementing this statute the Corps will be holding listening sessions by webinar for public input to inform the agency's implementation of the WRRDA 14. In addition to participation in these listening sessions, you are encouraged to provide any written views to us at any time.

Each of the listening sessions will cover a different collection of the more important general program policy provisions of WRRDA. These policy provisions have been categorized into general theme areas so that listening sessions can concentrate on two or more important theme areas or categories. The current conceptual framework for the listening sessions is as follows:
