# NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND NOTICE OF ADOPTION MEETING

#### REVISED DRAFT MODEL CRITERIA FOR GROUNDWATER MONITORING

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will receive public comments on revised draft Model Criteria for Groundwater Monitoring dated June 23, 2015 (revised draft Model Criteria) in areas of oil and gas well stimulation, as specified in California Water Code section 10783 (Senate Bill 4, Pavley, Statutes of 2013).

**NOTICE IS ADDITIONALLY HEREBY GIVEN** that the State Water Board will hold a public meeting to consider the adoption of the revised draft Model Criteria. Interested parties may provide oral comments on the revised draft Model Criteria at this meeting. Details of the public meeting are provided below.

### **BACKGROUND**

Water Code section 10783, subdivision (c), requires the State Water Board, on or before July 1, 2015, to develop Model Criteria in order to assess the potential effects of well stimulation treatments on the state's groundwater resources. Well stimulation is defined in Article 3 (commencing with section 3150) of Chapter 1 of Division 3 of the Public Resources Code.

The Model Criteria describe how area-specific groundwater monitoring will be conducted by oil and gas operators and how regional groundwater monitoring will be conducted by the State Water Board. Operators will be required to submit groundwater monitoring plans consistent with the Model Criteria to the State Water Board and appropriate Regional Water Board for approval prior to well stimulation activities. The regional monitoring program will assess potential effects that well stimulation and other oil and gas-related activities may have on groundwater quality.

The Model Criteria were developed in consultation with the Department of Conservation Division of Oil, Gas and Geothermal Resources, Regional Water Quality Control Boards, public stakeholders, and technical experts. Several stakeholder meetings have been held by State Water Board staff. Lawrence Livermore National Laboratory (LLNL), as the State Water Board's expert, has developed recommendations for the State Water Board to consider for the Model Criteria. LLNL's final recommendations are now available on the State Water Board's webpage identified below.

Proposed draft Model Criteria were released for a thirty-day public comment period on April 29, 2015. The State Water Board held a public workshop on May 19, 2015 to provide information, answer questions, and receive oral comments on the proposed draft Model Criteria. The deadline for submission of written comments on the proposed draft Model Criteria was 12:00 noon on May 29, 2015. Based on comments received on the proposed draft Model Criteria, staff has developed the revised draft Model Criteria dated June 23, 2015.
