



DWR begins construction for two new fish release sites

DWR has started construction of two new fish release sites, Little Baja and Manzo Ranch, on the northwest side of Sherman Island in Rio Vista. It has been nearly 40 years since DWR constructed fish release sites, which are used to return fish salvaged from the John E. Skinner Fish Protective Facility back into the Delta. The project is expected to be completed by December 2017. The project complies with the 2009 National Marine and Fisheries Service's Biological Opinion mandate to reduce predation and improve survival rates of salvaged fish returning to the Delta.
