



## SWRCB hearing officers issue ruling

On February 21, the State Water Resources Control Board's (SWRCB) hearing officers [issued a ruling](#) that responds to objections received to the admission of evidence in the hearing on the joint water right change petition filed by DWR and the U.S. Department of Interior for the California WaterFix Project. The letter also rules on the testimony and exhibits offered into evidence by the parties participating in Parts 1A and 1B of the hearing, establishes the deadline for written rebuttal testimony and exhibits, and provides notice of hearing dates for the rebuttal phase of Part 1 of the hearing.

DWR has also provided supporting information, including transmittal documents, data summary tables, analytical assumptions and limitations, and disclaimers relating to the submitted information.
