An Independent Review Panel was convened by select staff of the Delta Stewardship Council's [Delta Science Program](#) to provide the National Marine Fisheries Service, U.S. Fish and Wildlife Service, and California Department of Fish and Wildlife with the views of experts not involved in the Endangered Species Act consultation and 2081(b) permit on the use of best available scientific information in the California WaterFix Incidental Take Permit application.
