Bay Planning Coalition

Last week, the Bay Planning Coalition held its annual Spring Summit, which focused on Emergency Preparedness and Response. The event conveyed esteemed professionals and stakeholders for a timely discussion in light of recent weather events and our region's geographic potential for emergency events.

The summit included three thought-provoking panels that explored different aspects of emergency preparedness and response. From the first panel on funding, it is clear that the scope and considerations that inform emergency response have significantly changed in recent years. With more responsibilities and factors to consider, agency funding is necessary to support effective emergency response efforts.

The second panel on planning & permitting featured an informative review of agency plans and the steps taken to ensure an efficient response system is in place. The panel discussion emphasized the need for collaboration among operational area partners to ensure the effectiveness of pre-event plans and post-event actions.

The final panel covered emergency response implementation, where panelists explored the implementation of response strategies. With an informative discussion on panelists' experiences and best practices, the dialogue emphasized the multitude of variables that inform the operational aspects of emergency preparedness.
