Dredging & Beneficial Reuse Workshop

Tuesday, October 31st, 2023 | 9:00 am – 12:30 pm

CSUEB Conference Center – Downtown Oakland

Today, BPC held its annual Dredging & Beneficial Reuse Workshop in Downtown Oakland. This year's in-person event brought together a diverse group of industry experts, environmental professionals, regulators, and stakeholders for insightful discussions and networking opportunities.



The first segment provided attendees with regulatory updates and policy considerations with speakers from the San Francisco Bay Conservation and Development Commission, the San Francisco Regional Water Quality Control Board, and ENS Resources. Together, participants provided a thorough review of the existing and potential changes to the regulatory landscape related to dredging operations in the region.

The next segment, on beneficial reuse, featured site updates on Cullinan Ranch, Skaggs Island, Bel Marin Keys, and Montezuma Wetlands, as well as an update on the Section 1122 Strategic Placement Pilot Project and an industry perspective by Manson Construction. Participants shared recent successes of their respective projects and areas of improvement to increase the reuse of dredged sediment for restoration and adaptation efforts.

Given the region's high dredging cost, the last segment of the workshop focused on funding. Reviewing State, Federal, and private investment avenues to support the beneficial reuse of dredged sediment, BPC welcomed experts on each funding source to explore potential funding.

BPC Staff Retreat

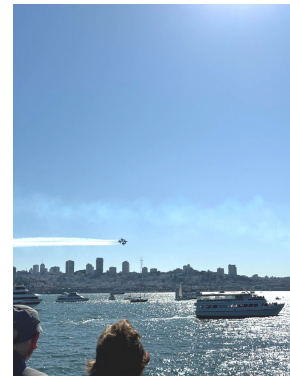
