BPC Management Update

CEO John Coleman's Departure

It is with mixed emotions that we announce that the Bay Planning Coalition's CEO, John Coleman, has notified BPC's Board of Directors of his resignation after thirteen accomplished years with our organization. John recently announced he has accepted another position and will resign not only from his role at BPC, but also from the East Bay Municipal Water District Board. As we embark on our leadership change process, we recognize the



value in reflecting on John's impressive accomplishments and the opportunity to assess ways to enhance BPC's organizational effectiveness and value going forward.

We have begun by looking back on John's tenure to recall how he has helped shape and grown BPC over the past 13 years. We immediately recognized that BPC's influence, relationships, and programming have expanded significantly throughout John's leadership of the organization, and the strong support from members and staff. The successful advocacy of local, state, and federal policies that reflect BPC's mission to ensure the sustainability of our region's economy and environment have been realized through our achievements and continued policy, legislative and regulatory engagements on all levels.

At the federal level, BPC has consistently promoted members and the region's interests through policy requests, with notable successes realized in the Water Resources Development Act (WRDA). In 2016, BPC played a critical role in developing language related to the beneficial use of dredged material through the development of Section 1122. This collaborative effort with BCDC, California State Coastal Conservancy, The Bay Institute, and Save the Bay led to its inclusion in the final Water Infrastructure Improvements for the Nation (WIIN) Act. Subsequently, funding for the Army Corps SF District's Shallow Water Strategic Placement Pilot Project was selected as one of ten projects in the nation, securing the funds necessary to further study the use of dredged material for resilience efforts in the San Francisco Bay.

Building on this momentum, BPC continued to advocate for the beneficial use of dredged material. Following the inclusion of language in WRDA 2020, the recent WRDA 2022 incorporated BPC policy requests prioritizing the beneficial use of dredged material for the region's adaptation efforts to encourage the enactment of existing provisions. As drafting of the 2024 Water Resources Development Act is currently underway, BPC remains actively engaged in advocacy efforts to secure additional beneficial use provisions to bolster the region's resilience while maintaining the commercial channels connecting our region to the global economy.

At the state level, BPC's advocacy for legislation has consistently reflected the environmental and industrial needs of the San Francisco Bay region. As the organization retains representation in agency appointments, legislation, and regulatory policies through effective relationships and a strong institutional knowledge of state politics, advocacy efforts to secure regional funding for infrastructure and adaptation efforts are among BPC's top priorities.

At the local level, the organization's collaborative approach to regional policies exhibits the ability of BPC to effectively represent our members when engaging with regulatory agencies. Bolstered by strong relationships with BCDC, SFRWQCB, BAAQMD, DMMO, and other regulatory bodies in the region, our organization continues to prioritize sound policies that foster a positive environment for industry success in the San Francisco Bay Region. Although we did not always agree with some agency actions, we always strived to seek compromises and solutions for a positive result. Advocacy engagements at a local level include: the development of BCDC's *BayAdapt* regional plan; the Regional Water Board's Basin Plan; AB 617 Community Action Plans; and multiple funding initiatives such as Measure AA. Underscoring our position on regional policies are BPC's long-term interests in streamlining the permitting processes, clarifying jurisdictional overlaps, and supporting a healthy environment in the region for generations to come.

BPC has and will continue to work with all our members to seek resolutions for numerous issues we face daily. The membership of BPC is the historical backbone of why we were created 40 years ago. Some issues change over time due to numerous factors, but our membership is critical to who and what we do, and that will remain the same.

To support the various levels of engagement, BPC's programming has systematically developed to expand the organization's education of members, stakeholders, and agencies through insightful dialogue and active collaboration. As BPC has grown, we have advanced our strategic goals through the work of six committees: Air Quality, Dredging & Beneficial Reuse, Energy & Water, Government Affairs, Sustainable Waterfronts, and Resilient Transportation. To complement the Committees' advocacy efforts and further the organization's mission, BPC events such as the annual Spring Summit and topical executive briefings serve as a valuable forum for thought exchange between the diverse industries that together form the Bay Planning Coalition.

We are actively engaged in planning for the Interim, the next six months, as well as the longer term. We recognize it would be difficult to hire another 'John Coleman'. At the same time, we value the opportunity to assess our current

organizational design and purposefully consider new ways to achieve our goals, continue to represent our region and take positive steps to enhance the relationships and successes of the past 13 years. We all wish John continued success as he begins his new assignment to manage the natural resources of Calaveras County Water District in March.

To our members and colleagues, the Board of Directors and staff appreciate your steadfast commitment to our shared mission. The Bay Planning Coalition looks forward to continuing our collaborative efforts.
