



Water Resources Workshop November 6th



Join BPC for our 2025 Water Resources Workshop in-person at East Bay Municipal Utility District's administrative offices in Oakland for an event bringing together water leaders and experts. Discussions will focus on sea level rise, groundwater, long-term resilience, and the strategies shaping our region's sustainable water future.

BPC is honored to welcome E. Joaquin Esquivel, Chair of the California State Water Resources Control Board, as this year's keynote speaker. A leading voice in California water policy, Chair Esquivel will share insights on advancing statewide goals of resilience, equity, and sustainability.

This workshop will have two segments:

Navigating Rising Waters: Sea Level and Groundwater in the Bay Area

This segment will explore the science behind sea level and groundwater rise, examine infrastructure vulnerabilities, and highlight how these changes can mobilize toxins from historic and industrial sites.





BPC Advocacy Efforts



Earlier this month, Bay Planning Coalition's Ad Hoc Committee on Permitting Efficiency received a presentation from the San Francisco Bay Conservation and Development Commission (BCDC) on its proposed rulemaking to update and modernize its permitting regulations.

As part of this process, BPC's committee had the opportunity to provide feedback on the draft proposal and share insights from the regulated community's perspective. The proposed rulemaking represents a significant step in BCDC's ongoing effort to streamline and clarify its permitting program to make it more efficient, transparent, and accessible to applicants.

Among the proposed updates, BCDC is seeking to:

- Streamline and improve the regionwide permit program
- Reduce permitting burdens for straightforward and routine activities
- Make other targeted updates to clarify and improve permitting rules

BPC will continue to monitor this rulemaking and engage with BCDC as the process advances to ensure that the proposed changes support both environmental protection and efficient project delivery around the Bay.
