Bay Planning Coalition recently launched a new briefing series hosted by our Resilient Shorelines Committee, focused on the challenges and opportunities of implementing shoreline adaptation projects and plans such as BCDC's Regional Shoreline Adaptation Plan (RSAP).

The first session focused on engagement in planning, with an emphasis on business and industry, and was held in a hybrid format at Moffatt & Nichols' Walnut Creek office and online. Representatives from BCDC and Civic Edge Consulting shared an overview of RSAP development and offered practical guidance on how shoreline stakeholders can engage in upcoming phases of the plan.

The series will continue with future sessions on topics including project financing, nature-based solutions, permitting, and innovative projects from other coasts and countries. Have a topic you'd like to see covered? Contact BPC staff with your ideas.

2025 Legislative Recap

Regional Advocacy: Permitting Efficiency



For the last several months, BPC has been engaged in BCDC's effort to modernize its own permitting regulations. BPC attended public hearings and provided feedback on the draft regulations, sharing insights from the regulated community's perspective.

The proposed rulemaking is a significant step toward streamlining the regionwide permit program, reducing permitting burdens for routine activities, and clarifying rules to make the process more efficient and transparent.

As part of our 2025 advocacy, BPC will continue to monitor the rulemaking and engage with BCDC to ensure that the proposed changes support both environmental protection and efficient project delivery across the Bay.

State Advocacy



Through our advocacy, BPC secured major wins in Sacramento, including critical funding increases and the prevention of unnecessary regulations.

We supported SB 762 (Arreguín), which advanced through the budget process and secured \$500,000 in one-time funding and \$55,000 in ongoing funds to launch a modern digital regulatory management system at BCDC, improving permitting, tracking, and enforcement.

BPC opposed SB 601 (Allen), which would have created duplicative “nexus waters” regulations and undermined an ongoing State Water Board study. The bill was held in Appropriations and deferred to 2026.

Working with partners, we also helped increase Proposition 4 climate bond funding in the final budget from \$2.7 billion to \$3.27 billion, with significant gains for coastal resilience. Funding for the State Coastal Conservancy doubled to \$62 million, and support for the San Francisco Bay Restoration Authority doubled to \$40 million.

We remain committed to advancing policies that protect the Bay, strengthen resilience, and support the region’s economy.

Federal Advocacy



In 2025, BPC advocated for key federal programs that support the San Francisco Bay and climate resilience. Working with Bay Area partners, we successfully defended the EPA’s San Francisco Bay Program, keeping its funding at \$54.5 million in the Senate and now advocating for \$24 million in the House. This program supports restoration, water quality, flood protection, and pollution reduction.

We also pushed for full FY2026 funding for the National Estuary Program, which strengthens estuaries, improves water quality, and boosts coastal resilience. The Senate maintained funding, and we are watching the House’s next move.

Finally, BPC joined the Subseasonal-to-Seasonal Forecasting Coalition, advocating for a \$15 million investment to improve short- to medium-term climate and weather predictions. These forecasts give communities and agencies crucial lead time for flood planning, water management, and other resilience efforts.

Our events were a major highlight of the year, made possible by the continued support of our sponsors, members, and partners. Nearly all were sold out, and feedback from attendees was overwhelmingly positive.

BPC kicked off 2025 with our annual Spring Summit, which focused on shifting priorities amid federal change and featured an excellent lineup of speakers.

In the fall, we hosted three workshops on dredging and beneficial reuse, water resources, and CEQA & regulatory updates. Each program offered timely insights to support the region and our members.

We concluded the year by bringing back BPC's Annual Luncheon, another sold-out gathering held at the City Club of San Francisco. The event featured remarks from City and County of San Francisco Mayor Daniel Lurie and brought together industry and regulatory leaders for a festive end to 2025.

Equally important were our committee meetings. Over the course of the year, we held ten meetings that provided members with opportunities to hear from outstanding speakers. These sessions not only offered timely insights but also informed and strengthened our advocacy work. From workshops to luncheons, our 2025 events and committee programs united members in ways that informed, inspired, and strengthened our regional community.
