#### Notice of California Environmental Quality Act Public Scoping Meetings September 2012

#### **CALIFORNIA ENVIRONMENTAL QUALITY ACT AND SUBMISSION OF COMMENTS**

Pursuant to CEQA, appropriate documentation will be prepared to analyze any potential adverse environmental effects associated with the proposed Statewide Biological Objectives Policy and Program of Implementation. The public meetings also serve as CEQA scoping meetings to solicit public input on the scope of the environmental analysis to be included in the CEQA document. Comments should be limited to assisting the State Water Boards to identify the range of actions, alternatives, mitigation measures, and potential significant environmental effects to be analyzed in the project environmental document and to eliminate issues that do not need to be evaluated in depth.

Oral comments received at the public meetings regarding the environmental analysis will be considered when preparing the CEQA document.

Interested persons are encouraged to submit written comments electronically. Comment letters may be submitted electronically, in pdf text format (if less than 15 megabytes in total size), to the Clerk to the Board via email at [commentletters@waterboards.ca.gov](mailto:commentletters@waterboards.ca.gov).
