# NOTICE OF PUBLIC HEARING

### PROPOSED AMENDMENT TO THE CALIFORNIA OCEAN PLAN REGARDING DESIGNATING STATE WATER QUALITY PROTECTION AREAS TO PROTECT MARINE PROTECTED AREAS AND THE DRAFT SUBSTITUTE ENVIRONMENTAL DOCUMENTATION FOR THE PROPOSED AMENDMENT

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will hold a public hearing to receive public input and comments on the proposed amendment to the California Ocean Plan (Ocean Plan) related to the State Water Board [Resolutions 2010-0057](#) and [2011-0013](#), designation of State Water Quality Protection Areas and Marine Protected Areas, and the draft substitute environmental documentation for the proposed amendment. A quorum of the State Water Board may be present; however, no Board action will be taken. The location and time of the public hearing is provided below.

## BACKGROUND

The Ocean Plan establishes water quality standards for California's ocean waters and provides the basis for regulation of wastes discharged into the State's near-coastal ocean waters. The Ocean Plan applies to point and nonpoint source discharges.

Section 13170.2 of the California Water Code directs the State Water Board to formulate and adopt a water quality control plan for ocean waters of California. The State Water Board first adopted the Ocean Plan in 1972. The current 2009 Ocean Plan is available from the State Water Board's Web site at:

The State Water Board adopted the Ocean Plan Triennial Review Workplan for 2011-2013 by Resolution 2011-0013 on March 15, 2011. The Workplan identifies numerous issues for which further action is needed. Issue 1, which is given very high priority, relates to the proposed State Water Quality Protection Areas amendment. #### **PARKING AND ACCESSIBILITY**


